

GDPR 2018 PRIVACY NOTICE

Introduction

This document refers to Personal Data, this is defined as information concerning any living person (a natural person who hereafter will be called the Data Subject) that is not already in the public domain.

The Data Protection Act (DPA), Privacy and Electronic Communications Regulations (PECR) and The General Data Protection Regulation (GDPR), which is EU wide and far more extensive, seek to protect and enhance the rights of Data Subjects. These rights cover the safeguarding of Personal Data, protection against the unlawful processing of Personal Data and the unrestricted movement of personal data within the EU. It should be noted that GDPR does not apply to information already in the public domain such as Companies House data.

Who we are

CEM is a manufacturer of pattern books & shade cards for the fabric and wallpaper industry.

Personal Data

CEM uses the information collected from you to provide quotations, make telephone contact and to email you marketing information, which the company believes, may be of interest to you and your business (please see Legitimate interests section below). On the occasion when CEM is working as a data processor on behalf of a partner or supplier, CEM will be acting on the instruction of its partner or supplier and will work to ensure that the data processing is fully GDPR compliant.

Some Personal Data may be collected about you from forms and surveys you complete, from records of our correspondence and phone calls and details of your visits to our website, including but not limited to personally identifying information like Internet Protocol (IP) addresses. CEM may from time to time use such information to identify its visitors. CEM may also collect statistics about the behavior of visitors to its website.

CEM's website uses cookies, which is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. WordPress.org uses cookies to help CEM identify and track visitors and their website access preferences. CEM's website visitors who do not wish to have cookies placed on their computers should set their browsers to refuse cookies before using CEM's website.

Any information CEM holds about you and your business encompasses details we hold about you and any sales transactions including any third-party information we have obtained about you from public sources such as credit referencing agencies. CEM will only collect the information needed so that it can provide you with our services, we will not sell or broker your data, although there may be times when your information could be contained in data that CEM Press has obtained from a third-party, in line with GDPR compliance.

Legal basis for processing any Personal Data

CEM Press takes your privacy seriously and will only use your personal information to administer your account and to provide the products and services you have requested from us.

Legitimate interests pursued by CEM

Our legitimate interest is to promote the products and services we provide. From time to time we would like to contact you with details of these products and services.

We process personal information for certain legitimate business purposes which include, some or all, of the following:

- Where the processing enables us to enhance, modify, personalize or otherwise improve our services/communications for the benefit of the customer.
- To identify and prevent fraud.
- To enhance the security of our networks and information systems.
- To better understand how customers interact with our social media and web sites.
- To provide postal communications which we think will be of benefit and interest to you.
- To determine the effectiveness of our promotional campaigns and our advertising.

Consent

Whenever we process data for these purposes we will ensure that we keep your Personal Data rights in the highest regard and uphold your data protection rights under current UK legislation.

Disclosure

CEM may disclose your Personal Information to meet legal obligations, regulations or valid governmental request. The company may also enforce its Terms and Conditions, including investigating potential violations of its Terms and Conditions to detect, prevent or mitigate fraud or security or technical issues; or to protect against imminent harm to the rights, property or safety of CEM, its customers and/or the wider community.

Retention Policy

CEM will process Personal Data during the duration of any business relationship with a company during which we provide products and services. We will continue to store only the Personal Data needed for five years to meet any legal obligations. After five years any Personal Data not needed, will be deleted.

Data Storage

Data is held in the United Kingdom. CEM does not store Personal Data outside the European Economic Area.

Your rights as a Data Subject

At any point whilst CEM is in possession of or processing your Personal Data, all Data Subjects have the following rights:

- Right of access you have the right to request a copy of the information that we hold about you.
- Right of rectification you have a right to correct data that we hold about you that is inaccurate or incomplete.
- Right to be forgotten in certain circumstances you can ask for the data we hold about you to be erased from our records.
- Right to restriction of processing where certain conditions apply you have a right to restrict the processing.
- Right of portability you have the right to have the data we hold about you transferred to another organization.



- Right to object you have the right to object to certain types of processing such as direct marketing.
- Right to object to automated processing, including profiling you also have the right not to be subject to the legal effects of automated processing or profiling.

If CEM refuses your request under rights of access, we will provide you with a reason as to why, which you have the right to legally challenge.

CEM, at your request, can confirm what information it holds about you and how it is processed.

You can request the following information:

- Identity and the contact details of the person or organization (CEM) that has determined how and why to process your data.
- Contact details of the Data Controller, where applicable (please see below).
- The purpose of the processing as well as the legal basis for processing.
- If the processing is based on the legitimate interests of CEM.
- The categories of Personal Data collected, stored and processed.
- Recipient(s) or categories of recipients that the data is/will be disclosed to.
- How long the data will be stored.
- Details of your rights to correct, erase, restrict or object to such processing.
- Information about your right to withdraw consent at any time.
- How to lodge a complaint with the supervisory authority (ICO).
- Whether the provision of Personal Data is a statutory or contractual requirement, or a requirement necessary to enter into a contract, as well as whether you are obliged to provide the Personal Data and the possible consequences of failing to provide such data.
- The source of Personal Data if it wasn't collected directly from you.
- Any details and information of automated decision making, such as profiling, and any meaningful
 information about the logic involved, as well as the significance and expected consequences of
 such processing.

To access what Personal Data is held, identification will be required -

CEM will accept the following forms of ID when information on your Personal Data is requested: a copy of your driving license, passport, birth certificate and a utility bill not older than three months. A minimum of one piece of photographic ID listed above and a supporting document is required. If CEM is dissatisfied with the quality, further information may be sought before Personal Data can be released.

Complaints

If you wish to make a compliant about how your Personal Data is being processed by CEM, you have the right to complain to the CEM Data Controller. If you do not get a response within 30 days, you can complain to the ICO.
